Terms & Conditions of Hire

1. Application for the hire must be made on the official booking form and forwarded to Mr Leadbeater trading as Heritage Motors (hereinafter referred to as the Proprietor) at the address shown. An application cannot be considered unless the applicant (hereinafter referred to as the Hirer) agrees to the terms & conditions of hire.

2. All agreed hire charges shall be payable by the Hirer **three months** before the date of the wedding and except as hereinafter provided no part thereof shall be returned.

3. Except as hereinafter provided the Proprietor shall not under any circumstances be liable to make any reimbursement or compensation or other payment to the Hirer in respect of, or to indemnify the Hirer against any loss, damage, costs, expenses or other liabilities incurred by the Hirer arising either directly or indirectly from the failure of the Proprietor to provide the agreed hire service due to the failure of the vehicle(s) to operate to the Hirer's reasonable satisfaction resulting from any defect in or breakdown or stoppage of the vehicle(s) or any accident or illness or other cause beyond the Proprietor's control.

4. If for any reason, the vehicle(s) hired is/are not available at the time of commencement of hire the Proprietor shall, if possible, offer to replace the vehicle(s) with alternative vehicle(s) but if this is not acceptable to the Hirer or if no alternative vehicle(s) is/are available, then the Hirer shall be entitled to a full refund of the hire charge or deposit paid, but shall have no other claim of any kind whatsoever against the Proprietor.

5. As our cars are in pristine condition, we ask you to help preserve them for future clients by respecting our 'No Smoking' policy and asking the chauffeur for assistance if the Bride & Groom (only) wish to have champagne in the car for photographs. For your safety, chauffeurs must also be allowed to open

and close car doors at your service at all times. We do not transport photographers or videographers.

6. Children should be accompanied by an adult who shall be responsible for children boarding and alighting the vehicle(s) safely. No food/drink shall be consumed in the vehicle(s) other than stated in condition (5).

We regret that we do not convey children under 24 months of age.

7. We regret that no space is available in the vehicles for push chairs, prams, wheelchairs, heavy luggage etc.
8. The hirer should be aware of the requirements of nominated passengers to be conveyed in comfort with regard to the stated limited seating capacity and the style of each vehicle to support able bodied people.
9. We pride ourselves on immaculate presentation of both vehicles and chauffeurs towards the enjoyment of everyone on your wedding day and we will try to fulfil all your wishes. However, unless previously agreed by the Proprietor, the Chauffeur's decision will be final.
10. NB. Surcharges may apply for additional journeys and for future fuel and emission charge increases post invoice date.
11. Bookings subject to any government/pandemic conditions at time of wedding.

A deposit is required to confirm and reserve this booking. (£100-00 per car)

Your non-refundable deposit (except condition 4) cheque/cash/bank transfer for **£100** payable to **Mr G. J. Leadbeater** should be returned with this completed Booking Form to the address overleaf.

I will send a reminder invoice for the balance of the charges and telephone you a few days before the wedding to confirm final arrangements.
